Bangladesh Cable Shilpa Limited is a state owned company which is the manufacturer of Telecommunication Copper Cables and Optical Fiber Cables. The Company invites application from bonafide citizens of Bangladesh to fill up the position of Managing Director, Head Quarter at Khulna.

The Managing Director is the Chief Executive of the company. He is responsible to lead a team with a large number of qualified professionals. He is responsible for overall management, e.g. administration, corporate planning, business development and ensuring the compliances of Laws, Rules and Regulations and Good Governance and legal functions of the organisation. He is also responsible for supervision of technical, financial, welfare aspects, negotiating any financing issues for the sake of the company with donors/development partners and listing the company in the Securities and Exchange Commission (SEC) etc.

Required Academic Qualifications:

The candidate must have **graduation in Engineering/ M.Sc/MBA** from any recognized university. Any relevant higher qualification (*MS, MBA for Engineers, PhD for all etc.*) or academic qualification on legal affairs would be an added advantage. The candidate must have **at least two 1st Division/Class in whole academic record with no 3rd Division/Class at any stage.**

Required experience:

Working experience of the candidate shall be **minimum 28(Twenty Eight) years** in any state owned organization/company with **at least 15(fifteen) years experience** in the field of administration/technical concern. The candidate should be efficient, dynamic, energetic, show initiative with assertive leadership ability that will ensure the vision and execute the mission for incremental ground of the company and excellent communication skills in Bangla and English and shall be capable of working in emergency situations.

Age limit:

Age limit should preferably be **between 52(fifty-two) and 62 (sixty-two) years** on the date of issuing the circular (**January 11, 2015**).

Remuneration/Compensation Package:

Remuneration/Compensation Package will be **fixed by the Board of Directors** of Bangladesh Cable Shilpa Limited.

Nature of Service:

The service shall be **on contract basis**. The initial contract period of the service shall be for 2 (two) years and is renewable for further one year based on his/her satisfactory performance in the company and as per approval of Board of Directors of the company.
