- f. FPS subscriber shall provide recorded voice-prompts (if necessary) in wav format (PCM, A-law, 8kHz, 16 bit, Mono) copied in a CD.
- g. Any feature or service may be changed in case of technical difficulties.
- h. Detail bill charge (on FPS subscriber's request) shall be Tk. 50/- for each A4 sized page.
- i. Any decision taken by BTCL authority will be treated as final regarding Free Phone Service.
